#### Waltrip Athletic Dept. Fundraiser

The Waltrip Athletic Department needs our help. Our new head coach, Todd Wright has sent us a list of equipment that they need to start this school year. I met with the PTSA president and the president of the Imperial Guard Alumnae to discuss sharing the list of items and each has agreed that we divide the list in thirds. HISD does not provide funds for the athletic equipment that has been requested. Usually, departments have fundraisers for their needs, but, since the new coaches have only been hired in the last few weeks, they could not plan a fundraiser in time before the school athletic program begins.


